In practice, any surplus funds are used to give grants to students at university or other further education institutions.

Who may apply for a student grant?:

- Students at university, college, other further education institutions, training courses etc.
- Students under 25 years old are deemed to be supported by their parents, while those over 25 years old are considered to be financially independent. Thus all applicants are required to complete Section 1 of the application form but Section 2, relating to parental income, need only be completed where the student is under 25 years old.
- Student grants are considered in conjunction with applications received by the Society for the Benefit of Sons and Daughters of the Clergy of the Church of Scotland and Esdaile Trust.
